#### §7235-B. Wildlife rehabilitation permit

2 The commissioner may issue a permit to a person to possess wildlife for the purpose of wildlife rehabilitation. There is no 4 fee for a wildlife rehabilitation permit. Rules adopted to implement this section are routine technical rules pursuant to 6 Title 5, chapter 375, subchapter II-A.' 8 Further amend the bill in section 13 by striking out that part designated "§7318." and inserting in its place the following: 10 '§7318. Violations by clients 12 14 A guide who has knowledge of a violation by a client of any of the provisions of chapters 701 to 721 shall, within 24 hours, er-as-seen-as-safely-pessible, inform a person authorized to 16 enforce those chapters.' 18 Further amend the bill in section 16 by striking out all of 20 subsection 9-A and inserting in its place the following: 22 Shooting from a motor vehicle or motorboat or '9-A. possessing a loaded firearm in a motor vehicle. Sec. 30. 12 MRSA §7553, sub-§1, ¶D, as enacted by PL 1989, c. 493, §44, is amended to read:

D. At East Outlet Dam in Sapling Township (T1R7) in 4 Somerset County and in Big Squaw Township (T2R6) in Piscataquis County at the outlet of Moosehead Lake, the 6 fishway and the area within 50 feet of any part of the fishway shall must be closed to fishing at all times.; and 8 Sec. 31. 12 MRSA §7553, sub-§1, ¶E is enacted to read: 10 12 E. There is no fishing in or from the fishway at the Sheepscot Lake Dam in the Town of Palermo in Waldo County. 14 Sec. 32. 12 MRSA §7558 is enacted to read: 16 §7558. No special fishing regulations on Big Machias River 18 Only the general fishing laws set forth in the open water 20 fishing regulations for 1998-1999 and 2000-2001, as adopted by the commissioner pursuant to section 7035, may be enforced on the 22 Big Machias River in Aroostook County from its confluence with the South Branch of the Machias River in T10R7 WELS to the Aroostook River in Ashland. This section is repealed September 24 1, 2001.' 26 Further amend the bill by inserting after section 30 the 28 following: 'Sec. 31. 12 MRSA §7824, sub-§2-B, as enacted by PL 1997, c. 30 227,  $\S3$ , is amended to read: 32 2-B. Antique snowmobile registration fee. A resident who 34 owns a snowmobile that is more than 25 years old and that is substantially maintained in original or restored condition may 36 register that snowmobile under this subsection as an antique snowmobile. An antique snowmobile registration authorizes that 38 snowmobile to be operated only for the purpose of traveling to, returning from and participating in an exhibition, parade or 40 other event of interest to the public or for occasional personal use. The fee for an antique snowmobile registration is \$30. An 42 antique snowmobile registration is valid until the ownership of that antique snowmobile is transferred to another person. Upon 44 the transfer of ownership, the new owner may reregister that snowmobile as an antique snowmobile by paying the \$30 antique 46 snowmobile registration fee. The registration fee for an antique snowmobile is allocated according to subsection 3, paragraph A. 48

Sec. 31. 12 MRSA §7825-C, as reallocated by PL 1999, c. 127, 50 Part A, §31, is reallocated to 12 MRSA §7798-B.'

2 Further amend the bill by striking out all of section 32 and inserting in its place the following:

'Sec. 32. Retroactivity. That section of this Act that 6 reallocates the Maine Revised Statutes, Title 12, section 7825-C applies retroactively to January 1, 1999.'

Further amend the bill by relettering or renumbering any 10 nonconsecutive Part letter or section number to read consecutively.

Further amend the bill by inserting at the end before the 14 summary the following:

**'FISCAL NOTE** 

in certain hunting license fees and the Changes 20 establishment of certification requirements for snowmobile rental agents and personal watercraft agents will result in insignificant increases of General Fund revenue collected by the 22 Department of Inland Fisheries and Wildlife from license and certification fees. 24

26 The Department of Inland Fisheries and Wildlife will incur some minor additional costs to issue wildlife rehabilitation 28 permits and to adopt rules pertaining to the permits. These costs can be absorbed within the department's existing budgeted 30 resources.

32 This bill may both increase and decrease prosecutions for Class E crimes. If a jail sentence is imposed, the additional 34 costs to the counties are estimated to be \$82.48 per day per prisoner. These costs are not reimbursed by the State. The net 36 impact on the county jail system is expected to be insignificant.

- 38 The net effect on the Judicial Department's workload and administrative costs will be minimal. The net effect on the 40 collection of fines will also be insignificant.'

#### **SUMMARY**

This amendment creates a wildlife rehabilitation permit, 46 allows snowmobiles registered as antique snowmobiles to be used for occasional personal use, prohibits any special fishing 48 regulations on the Big Machias River until September 1, 2001, prohibits fishing from the fishway of the Sheepscot Lake Dam in 50 Palermo and clarifies that it is not unlawful to have a loaded
