L.D. 2155, "Resolve, to Establish the Blue Ribbon Commission to Establish a Comprehensive Internet Policy"

Amend the amendment on page 3 by inserting after subsection 20 9 the following:

22 'Further amend the resolve by striking out all of section 6 and inserting in its place the following:

'Sec. 6. Compensation. Resolved: That legislative members are
entitled to receive the legislative per diem and reimbursement of necessary expenses for their attendance at authorized meetings of
the commission. Public members not otherwise compensated by their employers or other entities whom they represent are
entitled to receive reimbursement of necessary expenses and a per diem equal to the legislative per diem for their attendance at authorized meetings of the commission; and be it further'

Further amend the resolve in section 7 in the first and 2nd lines (page 2, lines 37 and 38 in L.D.) by striking out the following: "January 15, 2000" and inserting in its place the following: 'December 1, 1999' '

Further amend the amendment by striking out all of section 8 40 and inserting in its place the following:

42 'Sec. 8. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.
