increased salary for Legislators.'


#### FISCAL NOTE

This amendment increases the cost of the bill by \$726,841 in  
fiscal year 2000-01. A General Fund appropriation of \$790,364 is  
included in fiscal year 2000-01 for the Legislature for the costs  
related to the increased salary for Legislators.

The estimated additional General Fund appropriations that  
will be required for the costs related to the increased salary,  
as adjusted by the cost-of-living adjustment in fiscal years  
2001-02 and 2002-03, will be approximately \$448,833 and \$829,882,  
respectively.

#### SUMMARY

This amendment increases a Legislator's salary from \$10,500  
to \$14,400 in the first year of a legislative biennium and from  
\$7,500 to \$9,600 in the 2nd year of a biennium. These increased  
amounts represent approximately what a Legislator's salary would  
be now if there had been a cost-of-living adjustment provision in  
place since the time of the last adjustment to a Legislator's  
salary.
