HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to S.P. 770, L.D. 2168, Bill, "An Act to Implement the Recommendations of the State Compensation Commission"

Amend the amendment in the first indented paragraph after the title in the last line (page 1, line 25 in amendment) by striking out the following: "\$10,815" and inserting in its place the following: '\$12,600'

Further amend the amendment in the 2nd indented paragraph after the title in the last line (page 1, line 30 in amendment) by striking out the following: "\$7,725" and inserting in its place the following: '\$9,000'

Further amend the amendment in the 3rd indented paragraph after the title in the last line (page 1, line 35 in amendment) by striking out the following: "\$9,270" and inserting in its place the following: '\$10,800'

Further amend the amendment by striking out all of section 3 and inserting in its place the following:

'Sec. 3. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

6 **FISCAL NOTE**

8 This amendment increases the cost of the bill by \$362,558 in
fiscal year 2000-01. A General Fund appropriation of \$426,081 is
10 included in fiscal year 2000-01 for the Legislature for the costs
related to the increased salary for Legislators.

12 The estimated additional General Fund appropriations that
will be required for the costs related to the increased salary,
14 as adjusted by the cost-of-living adjustment in fiscal years
2001-02 and 2002-03, will be approximately \$320,400 and \$447,385,
16 respectively.

18 **SUMMARY**

20 This amendment increases the salary of a Legislator by 20%
22 from \$10,500 to \$12,600 in the first year of the legislative
biennium and from \$7,500 to \$9,000 in the 2nd year of the
24 biennium.
