HOUSE AMENDMENT "C" to COMMITTEE AMENDMENT "A" to S.P. 770, L.D. 2168, Bill, "An Act to Implement the Recommendations of the State Compensation Commission"

Amend the amendment in the 5th indented paragraph after the title in the first line (page 1, line 48 in amendment) by striking out the following: "2,"

Further amend the amendment in section 2 in the first line (page 2, line 2 in amendment) by striking out the following: "Sec. 2." and inserting in its place the following: 'Sec. 3.'

Further amend the amendment by striking out all of section 3 (page 2, lines 7 to 20 in amendment) and inserting in its place the following:

'Sec. 4. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

**FISCAL NOTE**

10 This amendment increases the cost of the bill by \$100,015 in  
12 fiscal year 2000-01 from the increased constituent service  
14 allowance for Legislators. A General Fund appropriation is  
16 included in fiscal year 2000-01 for this purpose. The estimated  
additional General Fund appropriations that will be required in  
fiscal years 2001-02 and 2002-03 for the increased constituent  
service allowance will be \$199,484 and \$100,015, respectively.
