## HOUSE AMENDMENT

HOUSE AMENDMENT "C" to COMMITTEE AMENDMENT "A" to S.P. 770, L.D. 2168

2 Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read 4 consecutively.

## **'FISCAL NOTE**

This amendment increases the cost of the bill by \$100,015 in 10 fiscal year 2000-01 from the increased constituent service allowance for Legislators. A General Fund appropriation is 12 included in fiscal year 2000-01 for this purpose. The estimated additional General Fund appropriations that will be required in 14 fiscal years 2001-02 and 2002-03 for the increased constituent service allowance will be \$199,484 and \$100,015, respectively. 16

## **SUMMARY**

20 This amendment retains the provisions of the bill that increase the annual allowance for constituent services for 22 Legislators.
