	Emergency preamble. Whereas, Acts of the Legislature do not
2	become effective until 90 days after adjournment unless enacted
4	as emergencies; and
-	Whereas, the authority of municipalities to bring certain

	A municipality may not commence a civil action against any
22	firearm or ammunition manufacturer for damages, abatement or
	injunctive relief resulting from or relating to the lawful
24	design, manufacture, marketing or sale of firearms or ammunition
26	to the public. This section does not prohibit a municipality
20	from bringing an action against a firearm or ammunition manufacturer or dealer for breach of contract or warranty for
28	firearms or ammunition purchased by a municipality.
30	Emergency clause. In view of the emergency cited in the
32	preamble, this Act takes effect when approved.
34	SUMMARY
36	This bill prohibits a municipality from bringing certain civil actions against firearm or ammunition manufacturers.
