This amendment specifies that a game warden is authorized to stop a motor vehicle only if the warden has a reasonable and articulable suspicion that a violation of any law of this State is taking place or has taken place or to protect public safety. The amendment also clarifies that this limitation may not impair a game warden's authority to participate in a roadblock.
