SUMMARY

This amendment removes the section of the bill that proposes to amend provisions for euthanasia of stray dogs. It changes the late fee for dog licensing from the current late fee of \$3 to \$5 for municipalities that do not issue a warrant and clarifies that, in municipalities that do issue late warrants, the late fee for dog licensing is \$10. It also removes language allowing the court to order a psychological evaluation for a person who violates the civil laws regarding cruelty to animals.
