Amend the amendment by inserting after Part F the following:

PART G

Sec. G-1. 5 MRSA §13058, sub-§10-A, as enacted by PL 1999, c. 776, §6, is repealed.

Sec. G-2. PL 1999, c. 776, §§24, 25, 26 and 28 are repealed.

PART H

Sec. H-1. PL 1999, c. 777, §2 is amended to read:

Sec. 2. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.
