This amendment is the minority report. It adds to the list of information that must be contained in camp lot leases the formula used to calculate lease fees, the time period covered by the lease and a description of the lot and its boundaries. It clarifies that the lessor must provide a copy of the insurance policy only when the lessor requires or provides insurance to lessees through a group plan.

The amendment also adds a fiscal note to the bill.
