### APPROPRIATIONS/ALLOCATIONS

#### Other Funds

The bill includes an Other Special Revenue funds allocation of \$500 for fiscal year 2000-01 for the Sea Cucumber Management Fund within the Department of Marine Resources. The amount of dedicated revenues that will be collected for this fund can not be determined at this time. The additional costs associated with adopting rules can be absorbed by the Department of Marine Resources utilizing existing budgeted resources.

This bill may increase prosecutions for Class D crimes. If a jail sentence is imposed, the additional costs to the counties are estimated to be \$83.36 per day per prisoner. The number of prosecutions that may result in a jail sentence and the resulting costs to the county jail system are expected to be insignificant.

The additional workload, administrative costs and indigent defense costs associated with the minimal number of new cases filed in the court system can be absorbed within the budgeted resources of the Judicial Department. The collection of additional fines may also increase General Fund revenue by minor amounts.'

#### **SUMMARY**

This amendment replaces the bill. The amendment closes the sea cucumber fishery to harvesting from July 1st to September 30th of each year. The amendment prohibits the use of a drag to 36 fish for sea cucumbers that exceeds 5 feet, 6 inches in width and requires the Commissioner of Marine Resources to adopt rules no 38 later than September 30, 2000 that describe the type of drag that may be used to fish for or take sea cucumbers.

The amendment establishes, but does not fund, the Sea 42 Cucumber Management Fund to be used to research and manage the 5tate's sea cucumber fishery and to enforce the laws related to 44 sea cucumbers. The amendment authorizes the joint standing committee of the Legislature having jurisdiction over marine 46 resources matters to report out a bill regarding regulation of the sea cucumber fishery to the Second Regular Session of the 48 l20th Legislature. The amendment adds an allocation section and a fiscal note to the bill.
