## **SUMMARY**

4 This amendment clarifies the intent of the original bill by limiting the amount of funds that may be deducted from a county's unorganized territory services reimbursement to funds that are designated by the Legislature for a specific purpose and that 8 were not spent by the county for that purpose. It also adds a fiscal note to the bill.
