10 provide Medicaid reimbursement for hospice services at a rate of \$130 per day per person and to provide hospice benefits to home12 and community-based care participants at the regular Medicare rate of \$98.

This bill also includes a Federal Expenditures Fund allocation of \$1,503,914 in fiscal year 2000-01 for the federal match associated with the costs of providing a hospice Medicaid benefit.'

SUMMARY

This amendment is the majority report and it amends the resolve to direct the Department of Human Services to provide a hospice Medicaid benefit. It appropriates and allocates funds for that purpose. It adds a fiscal note.
