Sec. 3. Payment for certification, authorization or approval. The

persons, including contracted services providers, schools and school districts, who have paid for the fingerprinting and
conducting of the needed state and national criminal history record checks by the Department of Public Safety, Bureau of State
Police, State Bureau of Identification, as required by the Maine Revised Statutes, Title 20-A, section 6103.

The amendment includes a General Fund appropriation of 10 \$175,000 in fiscal year 1999-00 to the Department of Public Safety to cover the cost of reimbursing certain school employees 12 who have paid for the costs of fingerprinting and background checks. The amendment also includes a General Fund appropriation 14 of \$279,300 to the Department of Public Safety in fiscal year 2000-01 for the costs of fingerprinting and background checks for The estimated future costs are also 16 new school employees. \$279,300 per year beginning in fiscal year 2001-02. These 18 amounts do not include the costs of conducting background checks and fingerprinting for all contracted service providers employed 20 by a public school. These amounts can not be determined at this time. Additional General Fund appropriations will be required to 22 cover the costs for this group of individuals.

The amendment also includes Other Special Revenue fund deallocations of \$410,000 and \$392,000 in fiscal years 1999-00 and 2000-01, respectively, for the Bureau of State Police within the Department of Public Safety to reflect the net reduced cost of background checks and fingerprinting. The department will also experience a corresponding loss of dedicated revenues from a decrease in the total amount of fees collected for the costs of conducting background checks and fingerprinting.

SUMMARY

Like the bill as amended by Committee Amendment "A," this amendment requires the State to pay the costs of the fingerprinting and background checks and reimburses those who have already paid for the fingerprinting and criminal history record checks. This amendment also limits application of the
