34	SUMMARY
36	This amendment strikes the appropriation section of the bill and replaces it with a new appropriation section and an
38	allocation section. The new sections organize "Adult Education"
40	into a separate program within the Department of Education and provide a 3% increase in the fiscal year 1999-00 and fiscal year 2000-01. It also adds a fiscal note to the bill.
