

Sec. 3. Joint Advisory Committee on Select Services for Older Persons. Resolved: That the Department of Human Services and the Department of Mental Health, Mental Retardation and Substance Abuse Services shall provide support for the Joint Advisory Committee on Select Services for Older Persons, referred to in this section as the "advisory committee." The advisory committee shall operate until December 31, 2002. The advisory committee shall study the special needs of older persons, including, but not limited to, services or treatment for mental health, mental retardation, substance abuse and dementia and shall advise the departments on services required to meet those needs. advisory committee shall monitor the development initiatives within both departments that serve older persons with special needs. The advisory committee shall report to the joint standing committee of the Legislature having jurisdiction over health and human services matters on February 1, 2001, August 1, 2001, February 1, 2002, August 1, 2002 and December 31, 2002.'
