school administrative unit or private school without monetary payment or benefits of any kind or amount.

4 2. Service restriction. A person may not serve as a volunteer in a school administrative unit or private school if that person would be denied a certificate, authorization or б approval under section 13020 if subject to certification, 8 authorization or approval.'

Further amend the amendment by relettering or renumbering 10 any nonconsecutive Part letter or section number to read 12 consecutively.

**FISCAL NOTE** 

16 This amendment will significantly increase the General Fund cost of the bill in fiscal year 2000-01. The amount can not be determined at this time. 18

## **SUMMARY**

This amendment requires a person who volunteers in a public 24 or private school to submit to the same criminal history record information checks as teachers or other education personnel who 26 apply for certification, authorization or approval.
