SENATE AMENDMENT "B" to S.P. 1031, L.D. 2611, Bill, "An Act to Appropriate Matching Funds for the Study of Nondefense Uses of the United States Naval Shipyard in Kittery, Maine"

Amend the bill by striking out the title and substituting the following:

'An Act to Protect and Enhance the United States Naval Shipyard in Kittery, Maine'

Further amend the bill by inserting before the summary the following:

'Sec. 3. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

Provides funds to the Department of the Attorney General to be used to meet legal costs related to legal proceedings concerning the location of the United States Naval Shipyard in Kittery, Maine. Unexpended funds do not lapse but carry forward

27 This amendment adds an appropriation to the bill to provide  
28 funds to the Department of the Attorney General to be used to  
29 respond to the complaint filed by New Hampshire against Maine in  
30 the United States Supreme Court seeking to resolve the dispute  
31 regarding the boundary between Maine and New Hampshire and  
32 requires the Attorney General to report to the joint standing  
33 committee of the Legislature having jurisdiction over  
34 appropriations and financial affairs concerning expenses incurred.
