## 'FISCAL NOTE

This bill requires that the Farmington Falls Standard Water District increase the number of trustees from three to five. The additional costs of this state mandate are estimated to be minor. Pursuant to the Mandate Preamble, the two-thirds vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional local costs.'
