- Sec. 1. Task force. Resolved: That the Secretary of State appoint a task force to study the requirements necessary to develop and implement a centralized voter registration list in order to:
 - 1. Eliminate duplicate registrations on a statewide basis;
 - 2. Administer automatic changes of address;
 - 3. Provide for systematic list maintenance activities; and
- 4. Produce current voter registration statistics and lists on a statewide basis, as well as by municipality, county and electoral district.

The task force shall investigate the use of the Internet as the infrastructure force linking all municipal jurisdictions to a centralized voter registration list, providing for real-time registration updates and ensuring against the possibility of certain types of voter fraud. The task force shall further investigate utilization this network the οf same electronically filing timely election results with the Secretary of State. The task force may apply for and accept federal or other funds for the purpose of implementing a centralized voter registration list; and be it further
