2 Furthest amend the bill in section 3 in subsection 5 by striking out all of the blocked paragraph (page 1, lines 43 to 45 4 in L.D.) and inserting in its place the following: 6 'A person operating a bicycle may return the hand used to signal a turn to the handlebars during the turn to maintain proper control\_of the bicycle.' 8 Further amend the bill by striking out all of section 4 and 10 inserting in its place the following: 12 'Sec. 4. 29-A MRSA §2084, sub-§1, as enacted by PL 1993, c. 14 683, Pt. A, §2 and affected by Pt. B, §5, is amended to read: Night equipment. A bicycle, motorized bicycle or 16 1. tricycle, when in use in the nighttime or-at-other-times-when 18 motor-vehicles-are-required-to-display-headlights, must have: 20 A. Lighted a front light that emits a white light visible from a distance of at least 200 feet to the front; 22 A red or amber light or reflector to the rear that is Β. visible at least 200 feet to the rear; and 24 26 C. Reflector strips material on the pedals and-handlebars. 28 A bicyclist must have reflector material on the foot or ankle. A bicyclist may also use optional supplementary reflectors, lights 30 or reflective or lighted safety equipment.' 32 Further amend the bill by relettering or renumbering any Part letter or section number to read nonconsecutive 34 consecutively. 36 Further amend the bill by inserting at the end before the summary the following: 38 **'FISCAL NOTE** 40 42 The additional workload and administrative costs associated with the minimal number of new cases filed in the court system can be absorbed within the budgeted resources of the Judicial 44 Department. The collection of additional fines may increase General Fund revenue by minor amounts. 46 The Bureau of State Police within the Department of Public 48 Safety will incur some minor additional costs to adopt certain

rules pertaining to bicycle safety. These costs can be absorbed within the bureau's existing budgeted resources.'

#### SUMMARY

This amendment changes the general definition of "bicycle" 8 in the Maine Revised Statutes, Title 29-A to be consistent with the definition of the Bicycle Safety Education Act. The amendment clarifies that bicycle operators are permitted to 10 travel on paved shoulders and that bicycle operators may replace 12 their hands on the handlebars after signaling a turn. The amendment updates the statutes regarding night equipment to 14 reflect current equipment and practices. The amendment clarifies that vehicles must yield to bicyclists when making right turns. This amendment also adds a fiscal note to the bill. 16
