COMMITTEE AMENDMENT " μ " to H.P. 390, L.D. 511

This section does not prohibit a minor under 16 years of age from performing work for a nonprofit organization that preserves film and other moving images and provides education and research opportunities for the public or for a theater that is operated by such an organization as an integral part of its mission.' SUMMARY 10 This amendment removes the language proposing to allow minors under 16 years of age to work in any nonprofit community therefore and instance to allow minors under 16 years of age to work in any nonprofit community
