26 28	'Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

30	Whereas, a sign posted on the Maine Turnpike contains an offensive and incorrect name and must be removed immediately; and

Further amend the bill by inserting at the end before the 8 summary the following: 10 12 **'FISCAL NOTE** 14 incur The Maine Turnpike Authority will some minor additional costs to replace certain highway signs. These costs can be absorbed within the authority's existing budgeted 16 resources.' 18 20 SUMMARY 22 This amendment clarifies that it is the responsibility of the Executive Director of the Maine Turnpike Authority, not the 24 Commissioner of Transportation, to replace signs with offensive names that are located on the Maine Turnpike.
