The amendment repeals the statutorily set motor vehicle inspection fees and allows vehicle 36 inspection stations to establish their own inspection fees, subject to a maximum fee level of \$12.50 for a standard 38 inspection, \$15.50 for an enhanced inspection on pre-1996 model vehicles pursuant to the Maine Revised Statutes, Title 29-A, section 1751, subsection 2-A and \$18.50 for an enhanced 40

subject to a maximum fee level of \$12.50 for a standard inspection, \$15.50 for an enhanced inspection on pre-1996 model vehicles pursuant to the Maine Revised Statutes, Title 29-A, section 1751, subsection 2-A and \$18.50 for an enhanced inspection performed on 1996 and later model vehicles pursuant to Title 29-A, section 1751, subsection 2-A. The amendment also increases the fee paid to the Chief of the State Police for vehicle inspection stickers from \$1.50 to \$2.50. This amendment changes the title of the bill to remove reference to inspection

of brake friction material since the amendment removed that portion of the bill.

The amendment also adds a fiscal note to the bill.
