An Act to Ensure Quality Home Care Coordination Services and Improve Long-term Care Services.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 22 MRSA §5107-I is enacted to read:

<u>§5107-I. Quality improvement committees</u>

The department shall establish quality improvement committees, referred to in this section as "committees," to 8 review the provision of home care services. The department shall 10require the participation of all contracting agencies that provide statewide coordinating services for consumers receiving 12 home-based care, Medicaid waiver for home- and community-based care, adults with disabilities and private duty nursing services 14 and any other program of home care for the elderly or disabled funded in whole or in part with state funds. The committee membership must also include representatives of consumers, 16 consumer advocates, including the long-term care ombudsman program, health care and service providers and representatives 18 from each area agency on aging.

 Chair: meetings. The members of each committee shall
choose a chair, who may not be a representative of the home care coordination agencies. Each committee must meet at least
quarterly.

 26 2. Duties. The duties of the committees include reviewing, evaluating and reporting on services provided to consumers of home care services. The services to be reviewed include care planning, implementation and modification, monitoring,
30 assessments and reassessments, continuity of care and consumer information, advocacy and support services.

3. Annual report. By March 1st each year, each committee
34 shall report to the department, the Long-term Care Steering
36 Committee established pursuant to section 5107-B and the joint
36 standing committee of the Legislature having jurisdiction over
38 health and human services matters concerning the committee's work
38 during the year, problems with the coordination of home care
39 services and the actions taken to resolve problems.

 4. Rulemaking. The department shall adopt rules to
42 implement this section. Rules adopted pursuant to this section are routine technical rules as defined in Title 5, chapter 375,
44 subchapter II-A.

Sec. 2. PL 1999, c. 731, Pt. BBBB, §15, first ¶ is amended to read:

Sec. BBBB-15. Establishment of the Long-term Care Implementation 2 Committee. There is established the Long-term Care Implementation Committee, referred to in this section as the "committee," to monitor the progress of state departments and 4 offices in implementing the provisions of this Part and the State's long-term care system. The committee shall review the б adoption and amendment of rules performed proposed in response to this Part and may make recommendations to the Department of Human 8 Services, to the Department of Mental Health, Mental Retardation and Substance Abuse Services and to the joint standing committee 10 of the Legislature having jurisdiction over health and human 12 services matters for regarding amendments to those rules. The committee shall review the quality of care in the long-term care 14 system.

SUMMARY

This bill establishes quality improvement committees for 20 home care services for the elderly and disabled, which will include representatives of the home care agencies, consumers, 22 consumer advocates, health care and service providers and representatives from each area agency on aging.

This bill directs the Long-term Care Implementation 26 Committee, established in Public Law 1999, chapter 731, Part BBBB, section 15, to monitor the work of state departments 28 pertaining to long-term care and directs the committee to review rules pertaining to long-term care and make recommendations to 30 the Department of Human Services, the Department of Mental Health, Mental Retardation and Substance Abuse Services and the 32 joint standing committee of the Legislature having jurisdiction over health and human services matters regarding amendments to 34 those rules.
