shall review the returns and, if it appears that a majority of 2 the legal votes are cast in favor of the Act, the Governor shall proclaim that fact without delay, and the Act takes effect 30 4 days after the date of the proclamation. 6 The Secretary of State shall prepare and furnish to each city, town and plantation all ballots, returns and copies of this 8 Act necessary to carry out the purpose of this referendum.' 10 FISCAL NOTE 12 This amendment changes the timing of sending this measure 14 out to referendum from November 2001 to November 2002. 16 The estimated cost of sending this measure out to referendum will vary according to the total number of referenda to be submitted to the voters in November 2002. The estimated cost to 18 the Secretary of State if one to 6 referenda are enacted is 20 \$121,392.
