summary the following: 4 **'FISCAL NOTE** 6 This resolve authorizes the Commissioner of Administrative and Financial Services to sell or lease a certain state-owned 8 property in the City of Hallowell. 10 Proceeds from the sale of this property accrue as dedicated revenue to the Bureau of General Services - Capital Construction 12 and Improvements Reserve Fund. Absent the provisions in section 7 of the resolve, proceeds from the sale or lease of this 14 property would accrue to the General Fund. The amount of 16 dedicated revenue from the proceeds of the sale of this state-owned property can not be determined at this time. 18 Allocations will be required to authorize expenditures from the amounts set aside in the Bureau of General Services - Capital Construction and Improvements Reserve Fund. 20 The amount and timing of the additional allocations required also can not be 22 determined at this time.' 24 SUMMARY 26 This amendment strikes and replaces the title of the This amendment strikes section 3 of the original 28 resolve. resolve and amends the resolve to authorize the Commissioner of Administrative and Financial Services to sell or lease the Jacob 30 Abbott House property in Hallowell with a suitable amount of land.
