	Requiring the Department of Defense, Veterans and Emergency
12	Management to administer the distribution of certain flags through its armories will reduce the General Fund cost of the
14	bill by \$57,850. As amended, this bill includes a General Fund appropriation of \$52,050 in fiscal year 2001-02 for the Division
16	of Purchases within the Department of Administrative and Financial Services to purchase flags for veterans' graves.
18	
20	The Department of Defense, Veterans and Emergency Management can absorb the costs of distributing the flags to its armories for pickup by municipalities within existing budgeted resources.
22	
24	SUMMARY
26	This amendment specifies that distribution of the flags will be by the Department of Defense, Veterans and Emergency
28	Management through the armories for pickup by the municipalities.
