32	The fund must be held separate and apart from all other money, funds and accounts. Any balance remaining in the fund at the end
34	of the fiscal year must be carried forward to the next fiscal year. The fund must be used to match \$1 for every \$3 a school
36	administrative unit pays for produce or minimally processed foods purchased directly from a farmer or farmers' cooperative in the State, to a maximum state contribution of \$1,000. At the end of
