## SUMMARY

This amendment is the minority report of the Joint Standing Committee on Education and Cultural Affairs. This amendment makes several provisions of the bill permissive rather than required; strikes the language in the bill requiring that a sex education course teach that homosexuality is not a lifestyle acceptable to the general public; and changes the purpose of the Maine Abstinence Program.

The amendment also adds a fiscal note to the bill.
