The plan must provide coverage for catastrophic health care services from a provider within this State if those services are determined medically necessary by the provider for the patient, except that the plan may not provide cosmetic services. The plan must provide coverage for catastrophic health care services after an enrollee has paid a deductible of \$10,000. Copayments or additional deductibles may not be charged to enrollees after that \$10,000 deductible has been met. This subsection does not preclude supplementary benefit insurance for services that are not medically necessary. Covered health care services must include all services and providers for which coverage is mandated under this Title.'
