Further amend the resolve in section 8 in the 4th line (page 3, line 35 in L.D.) by striking out the following: "March 1, 2002" and inserting in its place the following: 'December 1, 2001'

Further amend the resolve by striking out all of section 9 and inserting in its place the following:

'Sec. 9. Budget; grants. Resolved: That the chairs of the commission, with assistance from the commission staff, shall 10 administer the commission's budget. Within 10 days after its first meeting, the commission shall present a work plan 12 and proposed budget to the Legislative Council for approval. The commission may not incur expenses that would result in the 14 commission's exceeding its approved budget. Upon request from 16 the commission, the Executive Director of the Legislative Council shall promptly provide the commission chairs and staff with a 18 status report on the commission's budget, expenditures incurred and paid and available funds. The chairs of the commission may 20 seek and accept grants and other outside funding on behalf of the commission. Prompt notice of solicitation and acceptance of such funds must be sent to the Legislative Council. 22 All funds accepted must be forwarded to the executive director, along with 24 an accounting that includes amount, date received, from whom, purpose and limitation on use of the funds. The executive director administers any funds received; and be it further 26

existing budgeted resources. If an extension of the reporting
deadline is granted and the commission requires staffing assistance during the legislative session, the Legislature may
require an additional General Fund appropriation to contract for staff services.

The additional costs associated with the establishment of 8 the commission can be absorbed by the Department of Labor and the Department of Economic and Community Development utilizing 10 existing budgeted resources.'

SUMMARY

This amendment changes the membership of the Commission to 16 Study the Benefits and Costs for Increasing Access to Family and Medical Leave for Maine Families as follows: it adds a 18 representative of municipal employers and a parent or educator; it reduces the number of Senators and members of the House of 20 Representatives to one each, of different political parties; it changes the chamber of commerce representative to a member of the state chamber rather than the Kennebec Valley chamber and it 22 changes the Commissioner of Human Services to the Commissioner of 24 Labor. It also changes the deadline for the report and legislation from March 1, 2002 to December 1, 2001. Finally, it adds language regarding acceptance of outside funding, 26 an appropriation section, an allocation section and a fiscal note to 28 the resolve.
