COMMITTEE AMENDMENT 'B' to H.P. 1107, L.D. 1476

11. Inspections. The board or its agents er-assistants shall inspect-each-establishment conduct random inspections of licensed establishments and booths as considered necessary for compliance with the applicable requirements of this subehapter chapter and the applicable rules of the board adopted pursuant to this subehapter <u>chapter</u>. Each-establishment-must-be-inspected-at least-once-a-year-fer-compliance-with-the-applicable-laws-and rules-relating-to-the-public-health-and-safety-and-tho-conduct and-operation-of-establishments.

Sec. 3. Transition; change in board composition. Notwithstanding the Maine Revised Statutes, Title 32, section 14211-A, subsection 1, members of the Board of Barbering and Cosmetology on January 14 1, 2002 may remain members of that board until the completion of their terms. As board positions become vacant, members must be appointed in accordance with the changes to the composition of the board required by Title 32, section 14211-A, subsection 1, as amended by this Act.'

20 Further amend the bill by inserting at the end before the summary the following:

'FISCAL NOTE

26 The additional costs associated with changing the composition of the board and altering the inspection schedule can be absorbed by the Board of Barbering and Cosmetology within the Department of Professional and Financial Regulation utilizing 30 existing budgeted resources.'

SUMMARY

This amendment replaces the original bill. This amendment 36 changes the composition of the Board of Barbering and Cosmetology by reducing the number of barber and cosmetologist members and by 38 adding a manicurist and an aesthetician. This transition will be accomplished by attrition. The amendment also alters the 40 inspection schedule to make more efficient use of staff. The amendment also adds a fiscal note to the bill.
