#### **'FISCAL NOTE**

The Bureau of Family Independence within the Department of Human Services will incur some minor additional costs to provide notification to the custodial parent of the status and opportunity associated with the obligor becoming an assisted obligor. These costs can be absorbed within the bureau's existing budgeted resources.'

#### **SUMMARY**

This amendment is the majority report of the Joint Standing 40 Committee on Judiciary. It is recommended by the Family Law Advisory Commission, which proposed the bill.

It removes the proposed presumption concerning the obligor's capacity to pay child support and replaces it with a suspension of the child support obligation for an obligor who receives supplemental security income or public assistance for the benefit of a child of that obligor. It also adds a fiscal note to the bill.
