The estimated cost of sending this bond issue out to referendum will vary according to the total number of referenda enacted during the First Regular Session of the 120th Legislature to be submitted to the voters in November. The estimated cost to the Secretary of State if one to 6 referenda are enacted is \$121,392. Each additional referendum costs an additional \$8,000.

If approved by the voters, the total cost of this bond issue is estimated to be \$24,774,000 with principal payments of \$20,000,000 and interest payments of approximately \$4,774,000.

The additional costs associated with administering the funds received via this bond issue can be absorbed by the Department of Education utilizing existing budgeted resources.'

This amendment is the majority report. It increases the total amount of the bond issue from \$15,000,000 to \$20,000,000 and deletes a definition of public schools, which would have permitted the use of bond funds for the repair and improvement of certain private school facilities. It also adds a fiscal note to the bill.
