Resolved: That the commission shall study the economic and societal impact of the termination of camp lot lease arrangements and of the public enjoyment of state lands, including the lands of the unorganized territory, and develop a plan to preserve the traditional camp lot lease arrangements in and public enjoyment of state lands.
- 30 1. In conducting the study, the commission shall:
- A. Review the history of and recent changes to camp lot lease arrangements in state lands, including those of the unorganized territory;
 - B. Review the history of public enjoyment of state lands, including those of the unorganized territory, examining the economic impact of the termination of camp lot leases and of the loss of public enjoyment of those lands;
