Sec. 3. Retroactivity. That section of this Act that amends 6 Private and Special Law 1997, chapter 31, section 2 applies retroactively to the effective date of Private and Special Law 8 1997, chapter 31.

Sec. 4. Emergency clause; referendum; effective date. In view of the emergency cited in the preamble, this Act takes effect when 12 approved only for the purpose of permitting its submission to the legal voters within the district at a special or regular town 14 meeting or election held in the Town of Phillips and the Town of Avon prior to January 1, 2003. The election must be called, 16 advertised and conducted by the respective towns according to the 18 law relating to municipal elections. The registrars shall make a complete list of all the eligible voters. The list prepared by the registrars governs the eligibility of a voter. 20 For the purpose of registration of voters, the registrars of voters must be in session on the secular day next preceding the election. 22 The town clerks shall prepare the required ballots, on which the town clerks shall reduce the subject matter of this Act to the 24 following question:

- "Do you favor amending the charter of the Mt. Blue Standard Water District to accomplish the following: 28
- Remove the requirement that the treasurer of the 30 1. district be a trustee of the district;
- 2. Allow a person who is not a resident of the district but who is a customer of the district to serve as trustee of the 34 district; and
- 3. Require the salary of the treasurer and of the trustees to be subject to approval by the voters in the district 38 voting at a district meeting?"
- The voters shall indicate by a cross or check mark placed against the words "Yes" or "No" their opinion on the question. 42
- The results must be declared by the municipal officers of 44 the Town of Avon and the Town of Phillips and due certificate of the results filed by the town clerks with the Secretary of State. 46
- This Act takes effect immediately upon its acceptance by a 48 majority of the legal voters in the district voting at the Failure to achieve the necessary approval in any election. 50 referendum does not prohibit subsequent referenda consistent with

#### **SUMMARY**

This amendment clarifies certain language of the bill 8 relating to the hiring of a nontrustee as treasurer of the Mt. Blue Standard Water District and makes this provision retroactive 10 to the effective date of the law creating the district. It also allows a person who does not reside in the district to be a 12 trustee if the person is a customer of the district. It allows 14 treasurer, but makes the proposal subject to approval by the voters of the district. It makes these changes subject to 16 referendum approval.
