SUMMARY

This amendment strikes and replaces much of the original resolve. The amendment authorizes the Commissioner of Administrative and Financial Services to enter into purchase and sale agreements for the purchase of property or interests in property that are located within the limits of the capitol area in Augusta and identified for acquisition in the March 2001 Augusta State Facilities Master Plan Summary Report. The amendment also requires the purchase to be subject to legislative approval and appropriation. It also adds a fiscal note to the resolve.
