SENATE AMENDMENT "*A*" to COMMITTEE AMENDMENT "A" to S.P. 725, L.D. 1966, Bill, "An Act to Amend the Laws Relating to Development Districts"

Amend the amendment in section 1 in that part designated "**§5222.**" in subsection 13 in the last line (page 3, line 40 in amendment) by striking out the following: "preceding tax year" and inserting in its place the following: 'tax year preceding the year in which it was designated'

Further amend the amendment in section 1 in that part designated "**§5223.**" in subsection 3 in paragraph C in the 9th line (page 5, line 26 in amendment) by striking out the following: "designated after July 1, 2002" and inserting in its place the following: 'excluded from the calculation under former section 5253, subsection 1, paragraph C and any district designated on or after the effective date of this chapter'

Further amend the amendment in section 1 in that part designated "**§5224.**" in subsection 2 in paragraph I in the last line (page 7, line 26 in amendment) by striking out the following: "subsection 3" and inserting in its place the following: 'subsection 2'

Further amend the amendment in section 1 by inserting after that part designated "**§5243.**" the following:


Development districts and development programs designated before the effective date of this chapter remain in effect as authorized by law at the time of their designation and are governed by former chapter 207 as it existed immediately before its repeal except to the extent of any amendments to such development districts and development programs that are made in accordance with this chapter.'

SUMMARY

This amendment clarifies the law applying to municipal development districts and development programs designated before the effective date of the new chapter and corrects a typographical error.
