24	Amend the bill by striking out everything after the title and before the summary and inserting in its place the following:
26	'Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted
28	as emergencies; and
30	Whereas, submerged snowmobiles and motorboats in inland waters are a public health and safety hazard; and

34	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately
36	necessary for the preservation of the public peace, health and safety; now, therefore,

Notwithstanding Title 17, section 2267-A, subsection 3, the owner 2 or operator of a snowmobile that has been submerged or partially submerged as a result of a violation of this subsection shall remove the snowmobile within 24 hours of its submersion. The 4 owner or operator of a snowmobile submerged or partially submerged as a result of a violation of this subsection shall pay 6 any damages resulting from the submersion or removal. If the 8 owner or operator of a snowmobile submerged or partially submerged as a result of a violation of this subsection fails to 10 remove the snowmobile within 24 hours of its submersion, the commissioner may remove the snowmobile at the expense of the owner or operator or request in writing that the court direct the 12 owner or operator to remove the snowmobile immediately. 14 Sec. 2. 12 MRSA §7901-A, sub-§12, ¶B, as amended by PL 2001, c. 471, Pt. Definition. When used in this section the term "motor
 vehicle" means any self-propelled vehicle designed to carry persons or property or used to transport persons, except
 snowmobiles and meter-beats motorboats.

Notice of submerged vehicle, snowmobile or motorboat to 6 2. be given to department. The owner of any motor vehicle which that becomes submerged or partially submerged in the waters of 8 State, shall immediately, by the fastest the means of communication, notify the Commissioner of Inland Fisheries and 10 Wildlife of the event and the location of the vehicle. The owner 12 of a snowmobile or motorboat that becomes submerged in the inland waters of the State for more than 24 hours shall notify the commissioner as provided in this subsection. 14

16 The commissioner shall, upon receiving notice of a submerged or partially submerged vehicle in the waters of the State or a
18 submerged snowmobile or motorboat in the inland waters of the State, notify the Chief of the State Police, the Commissioner of
20 Environmental Protection and any municipality or public utility which that regulates the uses of the waters as a source of public
22 water supply pursuant to Title 22, sections 2641 to 2648.

24 Owner legally liable to remove vehicle, snowmobile or 3. motorboat. The owner of the vehicle shall-be is legally liable to remove any motor vehicle submerged or partially submerged in 26 the waters of the State and pay any damages resulting from the submersion or removal. The vehicle shall must be removed within 28 30 days of the submersion or partial submersion or within 30 days of "ice out" in the body of water unless the commissioner 30 determines that the vehicle creates a health or safety hazard. If the commissioner determines that the vehicle creates a health 32 or safety hazard he the commissioner shall order the owner to remove the vehicle immediately. If the owner fails to remove the 34 vehicle upon order of the commissioner, the commissioner shall, in writing, request the court to direct the owner to remove the 36 vehicle immediately. The owner of a snowmobile or motorboat that is submerged in the inland waters of this State for longer than 38 24 hours shall remove the snowmobile or motorboat in accordance 40 with this subsection.

42 4. Financial responsibility. A conviction or adjudication of any person for a violation of this section constitutes a
44 violation of state law relative to motor vehicles to which Title 29-A, chapter 13 applies.

5. Penalties. A conviction-or-adjudication-of-any-person for-a violation of this section is a civil violation for which a forfeiture of \$200 may be adjudged. In addition to a forfeiture,

or instead of a forfeiture, the judge may direct the person convicted to remove the vehicle, snowmobile or motorboat.

6. Rules. The commissioner may, in accordance with the provisions of the Maine Administrative Procedure Act, Title 5,
 chapter 375, promulgate any rules necessary to carry out the purposes of this chapter.

**Emergency clause.** In view of the emergency cited in the 10 preamble, this Act takes effect when approved.'

12 Further amend the bill by inserting at the end before the summary the following:

#### **'FISCAL NOTE**

18 This bill may increase prosecutions for Class E crimes. If a jail sentence is imposed, the additional costs to the counties 20 are estimated to be \$83.36 per day per prisoner. The number of prosecutions that may result in a jail sentence and the resulting 22 costs to the county jail system are expected to be insignificant.

24 The additional workload and administrative costs associated with the minimal number of new cases filed in the court system 26 can be absorbed within the budgeted resources of the Judicial Department. The collection of additional fines may increase 28 General Fund revenue or Other Special Revenue by minor amounts.'

### **SUMMARY**

This amendment is the majority report and adds an emergency 34 preamble and clause to the bill and requires the owner of a snowmobile or motorboat submerged in the inland waters of the 36 State for longer than 24 hours to notify the Commissioner of Inland Fisheries and Wildlife and requires the owner of that 38 submerged snowmobile or motorboat to pay damages resulting from the submersion. The amendment also prohibits the operation of a 40 snowmobile on the open water areas of public inland waters and requires that the owner or operator remove a snowmobile submerged 42 in violation of this section within 24 hours.

The amendment also adds a fiscal note to the bill.
