Whereas,** Acts and resolves of the 2 Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, this resolve establishes a commission to study county jail population, costs and reimbursement by the State; and

8 Whereas, in order for the commission to convene and complete its work in a timely fashion, it is necessary that this resolve 10 take effect as soon as possible; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

18 Sec. 1. Commission established. Resolved: That the Commission to Study County Jail Population, Costs and Reimbursement by the 20 State, referred to in this resolve as the "commission," is established; and be it further

Sec. 2. Commission membership. Resolved: That the commission consists of the following 9 members:

26 1. The Commissioner of Corrections or the commissioner's designee;

2. One representative of the Maine Jail Association, 30 appointed by the President of the Senate;

32 3. One representative of the Maine Sheriffs' Association, appointed by the President of the Senate;

4. One representative of the Maine Chiefs of Police 36 Association, appointed by the Speaker of the House;

38 5. One county commissioner, appointed by the Speaker of the House;

Two members of the Senate, appointed by the President of
 the Senate; and

44 7. Two members of the House of Representatives, appointed by the Speaker of the House; and be it further

Sec. 3. Chairs. Resolved: That the first named Senate member is the Senate chair of the commission and the first named House of Representatives member is the House chair of the commission; and be it further

Sec. 4. Appointments; meetings. **Resolved:** That all appointments must be made no later than 30 days following the 2 effective date of this resolve. The Executive Director of the 4 Legislative Council must be notified by all appointing authorities once the selections have been made. When the 6 appointment of all members has been completed, the chairs of the commission shall call and convene the first meeting of the commission no later than May 15, 2002; and be it further 8

Sec. 5. Duties. Resolved: That the commission shall study:

12 1. Initiatives for regional cooperation and solutions in building county jails;

2. Population of county jails, overcrowding and growth;

State probation violations, where those violations
 should be served and who should pay for the resulting incarceration;

Probation options, graduated sanctions and probation
 officer case load;

24 5. Criminal court case loads, whether cases are being handled in a timely fashion and whether there are sufficient
 26 judicial resources allocated to handle the current case load; and

28 6. Issues concerning female offenders in county jails; and be it further

Sec. 6. Staff assistance. Resolved: That, upon approval of the Legislative Council, the Office of Policy and Legal Analysis shall provide necessary staffing services to the commission; and be it further

36 Sec. 7. Compensation. Resolved: That the members of the commission who are Legislators are entitled to the legislative 38 per diem, as defined in the Maine Revised Statutes, Title 3, section 2, and reimbursement for necessary expenses incurred for 40 their attendance at authorized meetings of the commission. Other members of the commission who are not otherwise compensated by 42 their employers or other entities that they represent are entitled to receive reimbursement of necessary expenses incurred 44 for their attendance at authorized meetings; and be it further

46 Sec. 8. Report. Resolved: That the commission shall submit its report, together with any necessary implementing legislation,
 48 to the joint standing committee of the Legislature having jurisdiction over corrections and criminal justice matters no
 50 later than November 1, 2002. Following receipt of the report,

the joint standing committee of the Legislature having
jurisdiction over corrections and criminal justice matters may introduce legislation to the First Regular Session of the 121st
Legislature. If the commission requires a limited extension of time to conclude its work, it may apply to the Legislative
Council, which may grant the extension.

8 **Emergency clause.** In view of the emergency cited in the preamble, this resolve takes effect when approved.
