The Maine Cancer Registry Data Review Committee, referred to in this section as the "committee," is established. The 2 committee is appointed and convened by the Bureau of Health to review and advise the administrators of the statewide 4 cancer-incidence registry established in section 1404 on the 6 release of identifiable data as requested by researchers for the purposes of cancer prevention, control and research. The 8 committee is composed of not fewer than 3 members, representing training and experience in the fields of medical or public health research or disease prevention and control. The committee must 10 be quided by rules adopted by the Bureau of Health providing for the protection of the confidentiality of all cancer case data 12 reported to the registry.' 14 Further amend the bill in section 15 in subsection 3 in the first paragraph in the 6th line (page 4, line 45 in L.D.) by 16 striking out the following: "Sections" and inserting in its place the following: 'Parts' 18

## **'FISCAL NOTE**

The Bureau of Health in the Department of Human Services 12 will incur some minor additional costs to implement a number of changes to the laws regarding public health. These costs can be 14 absorbed within the department's existing budgeted resources.'

**SUMMARY** 

This amendment repeals the 3-day waiting period between 20 filing marriage intentions and marrying. It omits language on the release of cancer data. It allows handwritten or typewritten 22 entries on the medical certificate. It also adds a fiscal note to the bill.
