This amendment changes references to "Korean Conflict" in the resolve to "Korean War" and provides for the possibility of placing 2 plaques in the Hall of Flags, one honoring World War II veterans and one honoring Korean War veterans. The amendment also deletes the section of the resolve that established a study by the Maine Historic Preservation Commission to revise the method of dealing with future requests for adding commemorative items to the State House. This amendment also adds a fiscal note to the resolve.
