2 Further amend the amendment in Part AA in section 9 in the 2nd line (page 154, line 2 in amendment) by striking out the 4 following: "\$3,200,000" and inserting in its place following: **'\$5,120,730'** 6 **FISCAL NOTE** 8 This amendment will have no net effect on General Fund appropriations and revenue, and a balanced budget is maintained 10 for the 2002-03 biennium. 12 This amendment will increase the General Fund appropriations 14 to the Department of Education, Retired Teachers' Health Insurance program by \$1,920,730 in fiscal year 2002-03 to fund the increase in the State's contribution to 50% effective January 16 1, 2003. 18 The amendment also increases the transfer from the Fund for a Healthy Maine to the unappropriated surplus of the General Fund 20 by \$1,920,730 in fiscal year 2002-03. This transfer will reduce the projected balance remaining in the Fund for a Healthy Maine 22 at the end of the 2002-2003 biennium by \$1,920,730. 24 26 **SUMMARY** 28 This amendment increases the State's percentage of retired 30 teacher members' shares of health insurance to 50% beginning January 1, 2003 and takes the funds for this from the Fund for a 32 Healthy Maine. 34
