SENATE AMENDMENT "*B*" to COMMITTEE AMENDMENT "A" to H.P. 1593, L.D. 2096, "Resolve, to Promote the Interests of the People of Maine when Public Funds are Used to Acquire Conservation Easements"

Amend the amendment in section 4 in the last line (page 3, line 18 in amendment) by striking out the following: "resolve." and inserting in its place the following: 'resolve; and be it further'

Further amend the amendment by inserting after section 4 the following:

'Sec. 5. Funding. Resolved: That notwithstanding the Maine Revised Statutes, Title 5, section 6203, the State Controller shall transfer \$470 from the Land for Maine's Future Fund to the Legislature to fund the Legislator who participates in the working group. These funds must be used for all costs incurred to pay the per diem and expenses of the Legislator who participates in the working group; and be it further'

Further amend the amendment in section 5 in the 9th line (page 3, line 32 in amendment) by striking out the following: "**General Fund**" and inserting in its place the following: '**Other Special Revenue Funds**'

Further amend the amendment in section 5 in the last line (page 3, line 41 in amendment) by striking out the following: "**GENERAL FUND**" and inserting in its place the following: '**OTHER SPECIAL REVENUE FUNDS**'

out the purposes of this Act.


