## FISCAL NOTE

This amendment changes the funding source in Committee Amendment "A" from the Maine Rainy Day Fund to the Fund for a Healthy Maine. Transferring \$50,000 from the Fund for a Healthy Maine in fiscal year 2001-02 reduces the balance available in the fund by \$50,000.
