26 Further amend the amendment in section 3 in the 2nd line
28 (page 2, line 36 in amendment) by striking out the following:
"Maine Rainy Day Fund" and inserting in its place the
30 following: 'Fund for a Healthy Maine'

32 Further amend the amendment in section 3 in the 8th line
(page 2, line 42 in amendment) by striking out the following:
34 "Maine Rainy Day Fund" and inserting in its place the following:
'unallocated funds within the Fund for a Healthy Maine'

36 Further amend the amendment in section 3 in the 2nd line
38 from the end (page 2, line 48 in amendment) by striking out the
following: "Maine Rainy Day Fund" and inserting in its place the
40 following: 'Fund for a Healthy Maine'

42 Further amend the amendment by striking out all of section 4
and inserting in its place the following:

44 '**Sec. 4. Appropriations and allocations. Resolved:** That the


20 **FISCAL NOTE**

22 This amendment changes the funding source in the bill from
24 the Maine Rainy Day Fund to the Fund for a Healthy Maine.
Transferring \$50,000 from the Fund for a Healthy Maine in fiscal
26 year 2002-03 reduces the balance available in the fund by \$50,000.

28 The amendment includes an Other Special Revenue funds
allocation of \$50,000 in fiscal year 2002-03 for the Board of
30 Dental Examiners within the Department of Professional and
Financial Regulation to print and distribute a brochure and
32 poster on dental amalgam and alternatives.

34 **SUMMARY**

36 This amendment changes the funding source for the brochure
38 and poster from the Maine Rainy Day Fund to the Fund for a
Healthy Maine. The amendment also removes the emergency preamble
40 and emergency clause.
