## **FISCAL NOTE**

This amendment eliminates the General Fund appropriation to 4 the Department of Corrections to fund the costs of outside counsel fees. Instead, this amendment authorizes the Commissioner of Administrative and Financial Services to transfer 6 up to \$30,000 to the Department of Corrections from the 8 self-insurance fund or Risk Management Fund to offset the costs of outside counsel fees. This additional expenditure from the self-insurance fund will increase future insurance premiums 10 assessed against state agencies.

## SUMMARY

16 This amendment authorizes the transfer by the Commissioner of Administrative and Financial Services of up to \$30,000 from the self-insurance fund to the Department of Corrections to 18 offset the costs of outside counsel fees.
