FISCAL NOTE

42 This amendment removes the General Fund appropriation for the Task Force to Study the Impact of a Maine-based Casino. The 44 revised General Fund cost of the task force is estimated to be \$6,820 in fiscal year 2002-03. This cost can be absorbed within 46 the Legislature's existing budgeted resources utilizing available balance forward from fiscal year 2001-02.

## **SUMMARY**

This amendment has been prepared pursuant to action taken by the Legislative Council on March 26, 2002.

8 The amendment changes Legislator membership provisions; limits the task force to 4 meetings, one of which may be a public 10 hearing in the Augusta area; changes the report date; authorizes each of the 2 joint standing committees to report out a bill; and 12 removes the General Fund appropriation.
